EXTENDED CARE INFORMATION
2010-2011**

Early Arrival: Students are allowed to go directly to their classroom 10 minutes before classes begin. For your convenience we will provide student supervision at 7:00 a.m. for those parents who need to go to work. There is no charge for this service.

- ❖ PK3 – K5 students go to the Church Cafeteria.
- ❖ 1st – 5th Grade students go to the Lunchroom in the 300 Building.
- ❖ 6th – 12th Grade students go to the Upper School Lunchroom.

Late Stay: For those parents who need after school supervision:

- ❖ Early Childhood & Lower School - 2:50-6:30 p.m. There is no cost for students picked up by 3:15 p.m.
- ❖ Upper School – 3:15-6:30 p.m.
- ❖ Charges are billed monthly and you will receive a bill from the SFCS Business Office. Please refer to billing policy.
- ❖ Service Costs:
 - Plan A – pick up by 5:00 p.m. = \$12.00/day
 - Plan B – pick up by 6:30 p.m. = \$15.00/day
 - Once a student remains in Late Stay past the 5:00 p.m. cut-off for Plan A, they will be charged for the Plan B option, NO EXCEPTIONS.
 - A late fee will be assessed beginning at 6:30 p.m. at \$10.00 for each 15 minute interval, NO EXCEPTIONS.
- ❖ You may sign up for daily late stay or occasional use.
- ❖ We need as much notification as possible for occasional use to ensure space availability.
- ❖ All children enrolled in the Late Stay Program will receive an afternoon snack.
- ❖ Students have supervised play time inside and outside.
- ❖ Students have opportunity to complete homework assignments.
- ❖ PK3 – 5th Grade student late stay is located on the Lower School Campus.
- ❖ 6th – 8th Grade student late stay is located on the Upper School Campus.
- ❖ When students leave their primary area for other campus locations (gym, playground), a sign will be left directing you to your child’s location.
- ❖ Additional programs offered by SFCS are not included in the daily rate.
